AN ACT OF BILL

To further amend SC10-10-21 by creating a new Section 3-9 and change subsequent section to section 3-10, 3-11, 3-12, 3-13, 3-14, 3-15, 3-16, 3-17, 3-18, and 3-19 and for other purposes.


BE IT ENACTED BY THE SOKEHS MUNICIPAL COUNCIL

1 Section 1. Creating new section 3-9 under Chapter 3 of the Criminal Act
2 and change subsequent section to section 3-10, 3-11, 3-12, 3-13, 3-14, 3-15, 3-16,
3 3-17, 3-18, and 3-19 and for other purposes.

4 Section 2. The new section will be read as Section 3-9. **Appearance in**
5 **public under the influence of narcotics, drugs or alcohol.** A person is guilty of
6 appearance in public under the influence of narcotics, drugs or alcohol when he
7 appears in a public place under the influence of narcotics, drugs or alcohol to the
8 degree that he may endanger himself or other persons or property, or annoy persons
9 in his vicinity, and upon conviction thereof shall be imprisoned for a period of not
10 more than six months or fined not more than \$100, or both such fine and
11 imprisonment.

12 Section 3. This act shall become law upon approval by the Chief Magistrate
13 or upon its becoming law without such approval.
